(1) The number of underlying shares of common stock reported in Column 3 reflects a 1-for-.60 reverse stock split of the common stock effected in April 2017 as well as liquidation preferences accrued through May 11, 2017 (which preferences continue to accrue until the actual conversion of the Series A convertible preferred stock into common stock).
